A BILL

To prohibit a person from advertising for sale a product produced or manufactured using the forced labor of individuals in the People's Republic of China, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the "No Forced Labor on
5 TV Act".

1 **SEC. 2. PROHIBITION REGARDING PRODUCTS PRODUCED**
2 **USING FORCED LABOR.**

3 (a) PROHIBITION.—A person may not advertise for
4 sale a covered product.

5 (b) ENFORCEMENT BY COMMISSION.—

6 (1) UNFAIR OR DECEPTIVE ACTS OR PRAC-
7 TICES.—A violation of this section shall be treated
8 as a violation of a regulation under section
9 18(a)(1)(B) of the Federal Trade Commission Act
10 (15 U.S.C. 57a(a)(1)(B)) regarding unfair or decep-
11 tive acts or practices.

12 (2) POWERS OF COMMISSION.—The Commis-
13 sion shall enforce this section in the same manner,
14 by the same means, and with the same jurisdiction,
15 powers, and duties as though all applicable terms
16 and provisions of the Federal Trade Commission Act
17 (15 U.S.C. 41 et seq.) were incorporated into and
18 made a part of this section. Any person who violates
19 this section shall be subject to the penalties and en-
20 titled to the privileges and immunities provided in
21 the Federal Trade Commission Act.

22 (c) DEFINITIONS.—In this section:

23 (1) COMMISSION.—The term “Commission”
24 means the Federal Trade Commission.

25 (2) COVERED PRODUCT.—The term “covered
26 product” means a product produced or manufac-

1 tured, in whole or in part, using the forced labor of
2 individuals in the People’s Republic of China.

3 (3) FORCED LABOR.—The term “forced
4 labor”—

5 (A) has the meaning given that term in
6 section 307 of the Tariff Act of 1930 (19
7 U.S.C. 1307); and

8 (B) includes convict labor and indentured
9 labor under penal sanctions.

10 (d) EFFECTIVE DATE.—This section shall take effect
11 on the date that is 180 days after the date of the enact-
12 ment of this Act.
